No account required

ClassicTarot.ai does **not** require user accounts or logins. We do **not** maintain persistent account profiles.

We do not store your readings

Reading content is generated and shown to you, then **not stored** by ClassicTarot.ai. Closing your browser ends the session and the reading is **not retained** by us. If you request delivery by email, the reading appears in **your** mailbox; we do not keep a copy beyond what's technically needed to send it.

Delivery & email notice

- **Email and name are required** to request a reading.
- We cannot guarantee email receipt. Mailbox providers and spam filters may block or divert messages.
- **Guaranteed delivery** is the **on-screen display** in your web browser at purchase/session time.
- You are responsible for **entering a correct email address** and **checking inbox and spam/junk folders**.

What we process & why

- **Name and email:** to deliver your reading (if requested by email), send receipts, and provide support — **Contract** (Art. 6(1)(b)).
- **Our own updates & reminders (optional):** emails about **new features** and **reading reminders** (no third-party promotions):
 - **Option A — Explicit consent:** only if you **opt in** — **Consent** (Art. 6(1)(a)); withdraw any time via unsubscribe or email.
 - **Option B — Existing-customer soft opt-in:** if you've purchased/used our service, we may email you about **our own similar services/features** (including feature updates and reading reminders) — **Legitimate interests** (Art. 6(1)(f)). You can **opt out at collection and in every email**.

Resending & refunds

Because readings are **ephemeral** and **not stored**, we cannot reproduce or resend a reading after delivery or after your browser session ends. For the same reason, **refunds are not available once the reading has been delivered**.

EU/UK note: At checkout we ask you to confirm immediate performance and acknowledge that you **lose the 14-day right of withdrawal once delivery starts** (digital content rule).

Collection-point wording (choose one)

Hosting, email delivery, analytics, and payment providers act under our instructions and data-processing agreements. We do **not** sell your data or allow others to use it for their marketing.

International transfers

If data leaves your region (e.g., EEA/UK), we use lawful safeguards such as Standard Contractual Clauses or adequacy decisions.

Retention

- **Reading content: not collected and not stored** by us.
- **Contact details:** retained while we provide your reading/support and until you unsubscribe or request deletion.
- **Payment/transaction records: 7 years** for legal/accounting.

Your rights
